RPG Life Sciences outperforms industry consecutively for 6 quarters.

Q2 Growth: 22% SALES, 39% PBT

Mumbai, October 21, 2016: RPG Life Sciences Ltd, part of the Rs 21,000-crore RPG Group, engaged in manufacturing and marketing of pharmaceutical products, has demonstrated six consecutive quarters of sustained above industry growth.

The company's net sales for Q2 2016 stands at Rs. 76.38 crore, a growth of 22% while the PBT at Rs. 4.28 crore demonstrates a growth of 39% on a like-to-like basis i.e., without including the biotech business that was sold to Intas Pharmaceuticals.

PAT for the quarter was Rs. 10.25 crore and includes an exceptional profit of Rs 7.38 crore on account of sale of the biotech business which was concluded at the end of first quarter.
